Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the respondents and their subordinates not to interfere with possession and enjoyment of the petitioners over the land bearing plot nos. 1577, 1665, 1666, 1669, 1701, 1710, 1706, 1782, 1783, 1800 & 1858, admeasuring 200 sq. yards each, part and parcel of Lakshmi Mega City-II, under Sy. Nos. 52, 53, 54, 55, 57, 86 & 87 of Pedda Shapur Village, Shamshabad Mandal, Ranga Reddy District, without following the procedure as contemplated under law, pending disposal of WP No. 17127 of 2020, on the file of the High Court.

The court while directing issue of notice to the Respondents herein to show cause as to why this application should not be complied with, made the following order. (The receipt of this order will be deemed to be the receipt of notice in the case).

**ORDER:**

"In identical circumstances, in I.A.No.1 of 2020 in W.P.No.34 of 2020, this Court taking into consideration the rights of the petitioner therein, *vide* order dated 03.01.2020, had directed the respondents therein not to carry out any work and not to interfere with the possession and enjoyment of the petitioner over the subject property without following due process of law.

Now, the allegation of the petitioners in the present writ petition is that the Gram Panchayat authorities are interfering with their possession and enjoyment over the subject land.

In the light of the order passed in the afore-stated writ petition, the respondents are directed not to interfere with the possession and enjoyment of the petitioners over the subject land."
