Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue Writ, Order or direction more particularly the nature of Writ of Mandamus declaring the action of the 3rd respondent in leasing the shop No.2 vide door no.4-4-5/13 situated at Adilabad Municipality to the 4th respondent even when there is existent lease deed, dated: 01.01.2021 to 31.12.2030 in favour of petitioner and trying to dispose the petitioner from the said property which is illegal, arbitrary Unjust, improper and violative of the principles of natural justice and consequently set-aside the same and continue the petitioner as per lease deed dated: 01.01.2021.
