WHEREAS the Petitioner above named through his Advocate M/s S. VIPLAV SIMHA REDDY presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ or order/ direction one in the nature of writ of mandamus aggrieved by the action of the 3rd respondent in issuing the proceedings vide proc No.TSTDC/Admn/P1/55/2014 dated 20/01/2021, where by rejecting the claim of the petitioner seeking restoration of his seniority in the cadre of common category under Junior Accountant and consequential promotion to the post of Assistant General Manager (Accounts) on par with 4th respondent being not tenable, the same being illegal, irregular and in violation of principles of natural justice and very much in violation of Article 14 and 16 of Constitution of India and consequentially direct the respondent Nos.2, 3 to revise petitioner's seniority by giving notional promotion with effect from the date on which the 4th and 6th respondent was promoted and grant all benefits attended by virtue of the said promotion and re-fixing of petitioner seniority in the interest of justice.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of M/s S. VIPLAV SIMHA REDDY, Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
