WHEREAS the Petitioner above named through his Advocate Sri PINGALI LAKSHMI presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction, more particularly, one in the nature of Writ of Mandamus, declaring the action of the respondents in not absorbing the petitioners into Government service on par with the aided staff absorbed into Government service in terms of the G.O.Ms.No.1, dated 03-01-2018, as illegal, arbitrary, violation of Article 14, 16, 21 and 300-A of the Constitution of India, and against the principles of natural justice, and consequently direct the Respondents to absorb the petitioners into Government Service as per G.O.Ms.No.1, dated 03-01-2018 with effect from 03-01-2018 with all consequential benefits.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri PINGALI LAKSHMI Advocate for the Petitioner, Government Pleader for Services takes notice for respondents Nos. 1,2 and 3. directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
