WHEREAS the Petitioner above named through his/her Advocate SRI MADIRAJU PRABHAKAR RAO presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue any Writ, order or direction more particularly one in the nature of Mandamus declaring action of the respondent No. 4 in filing E.P.No.139 of 2022 IN ARB.Dis.No.174 of 2014 on the file of Principal Junior Civil Judge at Khammam for execution of exparte award dt. 18.03.2015 passed by the

respondent No.3, as illegal, arbitrary, and contrary to the provisions of the Chit Funds Act, 1982 and Rules and against the law held by this Honble Court in Punyamurthala Venkata Viswa Sundara Rao -Vs- Margadari Chit Fund Private Limited, Hyderabad and others (reported in 2017 (3) ALD 387) and consequently to declare that E.P.No.139 of 2022 IN ARB.Dis.No.174 of 2014 filed by the respondent No.4 is not maintainable and the same is liable to be rejected;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri. MADIRAJU PRABHAKAR RAO, Advocate for the Petitioner and GP for Revenue for the Respondent Nos.1 to 3, directed issue of notice to the Respondent Nos.4 to 7 herein to show cause as to why this WRIT PETITION should not be admitted.

are directed to show cause on or before 20-07-2026 to which date the case stands posted as to why in the circumstances set out in the petition and the affidavit filed therewith (copy enclosed) this WRIT PETITION should not be admitted.

I.A. NO: 1 OF 2026

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to stay all further proceedings in E.P.No.139 of 2022 IN ARB.Dis.No.174 of 2014 on the file of Principal Junior Civil Judge at Khammam, Pending disposal of WP No 13355 of 2026, on the file of the High Court.

The Court made the following:

ORDER

Notice before admission.

Learned Government Pleader for Revenue General (Stamps and Registration) takes notice on behalf of respondent Nos.1 to 3, waives further notice and seeks time to file counter.

Registry is directed not to take out notice to respondent Nos.1 to 3 in view of the above waiver.

The learned counsel for the petitioner is permitted to take out personal notice to respondent Nos.4 to 7 and to file proof of service in the registry.

The learned counsel for the petitioner submits in *Punyamurthula Venkata Viswa Sundara Rao v. Margadarsi Chit Fund Private Limited, Hyderabad and others* [2017(3) ALD 387], the Division Bench of this Court held that the E.P. Court does not have jurisdiction to entertain an application for execution of the award passed by the Deputy Registrar of Chit Funds, if presented by the decree holder. However, in the instant case also, straightaway E.P.No.139 of 2022 in Arb.Dis.No.174 of 2014 was filed before the Principal Junior Civil Judge, Khammam, against the petitioner and others, without it being presented/forwarded by the Registrar. In view of the decision referred to above, balance of convenience is in favour of the petitioner.

Hence, there shall be interim stay as prayed for insofar as petitioner is concerned.
