ORDER :

This Civil Revision Petition under Article 227 of the Constitution of India, is filed being aggrieved by the orders passed in I.A.No.125 of 2025 in O.S.No.91 of 2025 dated 6.5.2025 on the file of the learned Principal Junior Civil Judge, Gajwel.

2. Heard Sri K.Pradeep Reddy, learned counsel appearing for the revision petitioners. During the course of arguments, the learned counsel confined his prayer seeking direction to the Court below to dispose of the pending application i.e. I.A.No.125 of 2025 in O.S.No.91 of 2025 within a reasonable period of time.

3. A perusal of the record, it discloses that the learned Principal Junior Civil Judge, Gajwel has initially granted ad-interim injunction in favour of petitioners/plaintiffs vide order dated 6.5.2025 in I.A.No.125 of 2025 in O.S.No.91 of 2025 and thereafter, the said order was extended on 10.6.2025, 27.6.2025, 7.8.2025, 4.9.2025, 7.10.2025 and on 21.11.2025. The interim order was extended till 22.12.2025. Thereafter, there was no extension and without extending the order, the matter was simply adjourned to 29.1.2026, 26.2.2026, 5.3.2026 and 17.3.2026.

4. In view of the above and without going into merits of the matter, it is appropriate to direct the learned Principal Junior Civil Judge, Gajwel to dispose of I.A.No.125 of 2025 in O.S.No.91 of 2025, as expeditiously as possible, preferably before Summer Vacation, 2026.

5. The Civil Revision Petition is accordingly disposed of. Pending miscellaneous petitions, if any, shall stand closed. No costs.

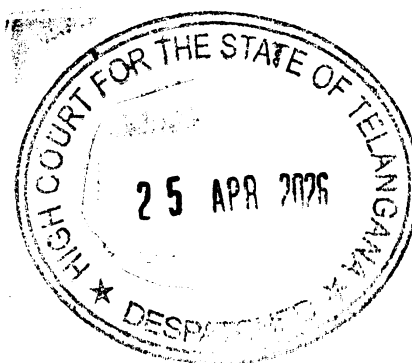
