Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ or Direction more particularly one in nature of WRIT OF MANDAMUS declaring the action of the Respondents in dispossessing the Petitioners from their respective plots in Survey Nos. 44/5 under Sub-division Nos. 3, 9 and 10, situated at Maqtha Mahaboobpet Village, Serilingampally Mandal and Municipality, under GHMC, Ranga Reddy District, Telangana State without following due process of law as illegal, unjust, arbitrary, violative of principles of natural justice and consequently, direct the Respondent Nos.3 to 6 not to interfere, dispossess and demolish the structures of the plots and structures from the peaceful possession and enjoyment of the Petitioners over their respective Plots without following the due procedure.

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the Respondent Nos.3 to 6 not to interfere, dispossess and demolish the structures of the plots and structures from the peaceful possession and enjoyment of the Petitioners over their respective Plots without following the due procedure, pending disposal of WP No 13464 of 2026, on the file of the High Court.
