Petition under Article 226 of the Constitution of India, praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or Direction, more particularly one in the nature of Writ of Mandamus, declaring the action of the respondent authorities in threatening to dispossess the petitioner from his land in Sy. No. 818 admeasuring Ac. 5.00 gts., situated a Chennapuram, Shameerpet, Kapra Mandal, Medchal Malkajgiri District, without any notice and without following the procedure contemplated under the Statute, as being illegal, arbitrary, unjust and unconstitutional and consequently direct the respondent authorities not to take any coercive steps without following the due process of Law;

Petition under Section 151 of C.P.C, praying that in the circumstances stated in the affidavit filed in the writ petition, the High Court may be pleased to direct the respondent authorities not to dispossess or in any manner interfere with the possession and enjoyment of the petitioner in the land in Sy. No. 818 admeasuring Ac. 5.00 gts., situated a Chennapuram, Shameerpet, Kapra Mandal, Medchal - Malkajgiri District, pending disposal of WP No. 13705 of 2026, on the file of the High Court.

arguments of Sri Karunakar Reddy, Advocate for the Petitioner, Asst. GP for Revenue, for Respondent Nos. 1 to 3, and Sri G.Madhusudhan Reddy, Standing Counsel for GHMC/Respondent No.4, the Court made the following.

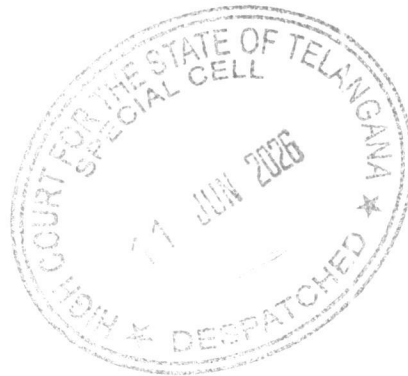
