Petition under Article 226 of the Constitution of India, praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or Direction, more particularly one in the nature of Writ of Mandamus, declaring the action of the respondent authorities in threatening to dispossess the petitioner from his land in Sy. No. 818 admeasuring Ac. 5.00 gts., situated a Chennapuram, Shameerpet, Kapra Mandal, Medchal Malkajgiri District, without any notice and without following the procedure contemplated under the Statute, as being illegal, arbitrary, unjust and unconstitutional and consequently direct the respondent authorities not to take any coercive steps without following the due process of Law;
