JAGAN presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ, order or direction more particularly one in the nature of WRIT OF MANDAMUS declaring the proceedings No. L1/785 (133) /2016-SR, dated 05.05.2018, of the 2<sup>nd</sup> respondent in rejecting, not paying the salary from 26.08.2014 to till date and not providing suitable alternative employment is illegal, arbitrary, contrary to the provisions of TSRTC Service regulations, The Rights of Persons with Disabilities Act, 2016 ( Act 49 of 2016), settlement entered under section 12 (3) of the Industrial Dispute Act and as well as the fundamental rights guaranteed under the constitution of India set aside the same consequently direct the respondents to pay the salary from 26.08.2014 to till date and to provide a suitable alternative employment with all service attendant benefits.
