b. the Assessment Order passed by the 1st Respondent DIN and Order No.ITBA/AST/S/143A(3)2021-22/1032553935(1), for the Assessment Year 2019 - 20, dated 20/04/2021, as arbitrary, illegal, bad in law, without jurisdiction and violative of principles of natural justice, and to consequently set aside the same in the interests of justice; ✓

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri A V A SIVA KARTIKEYA, Advocate for the Petitioner and Sri B.
