WHEREAS the Petitioners above named through their Advocate Sri. DR K LAKSHMI NARASIMHA presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased issue a Writ or order preferably in the nature of Writ of Mandamus declare that the petitioners herein are entitled to be promoted as Chief Engineers (Telecom) on par with the Respondent No.2 junior with effect from 12-6-2017 with all consequential benefits like arrears of pay/salary etc and consequently declare the action of the 1st Respondent in not promoting the petitioners as Chief Engineers (Telecom) with effect from 12-6-2017 as illegal, arbitrary, contrary to law and violative of Articles 12,14,16 and 21 of Constitution of India and consequently direct the 1st Respondent to promote the petitioners as Chief Engineer (Telecom) with effect from 12-6-2017 with all benefits like pay, arrears of pay/salary etc and consequently refix the pension with all consequential benefits;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri DR K LAKSHMI NARASIMHA Advocate for the Petitioners and Ms.V.Uma Devi, learned Standing Counsel for TS TRANSCO takes notice on behalf of respondent No.1, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.

Pending the writ petition, there shall be interim direction to respondent No.1 to consider the representation of the petitioners dated 16.4.2024 and pass appropriate orders thereon, in accordance with law, as expeditiously as possible, preferably within a period of six weeks from the date of receipt of a copy of this order and communicate the decision to the petitioner.
