Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to pass an order or direction or writ more particularly in the nature of Mandamus duly declaring the action of 4th and 5th respondents in attempting to evict the petitioners from their property and putting the description of the property in the Dharani Portal/ BhuBharathi portal as Not signed - Dispute in Succession, vide an extent of Ac.3.2000 Guntas situated in Survey Number 314/ 172, situated at Samithisingaram Village, of Manuguru Mandal, Bhadradi Kothagudem District, without any notice or proceedings, as illegal, arbitrary and against the principles of natural justice and consequently direct the said respondents not to interfere with the peaceful possession and enjoyment of the above property and the remove the description of the property in the Dharani Portal/ BhuBharathi portal as Not signed - Dispute in Succession.

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the respondents 4 and 5 not to interfere with the peaceful possession and enjoyment of the petitioners property vide an extent of Ac.3.2000 Guntas situated in Survey Number 314/172, situated at Samithisingaram Village, of Manuguru Mandal, Bhadradri Kothagudem District in the interest of justice, pending disposal of WP No 14370 of 2026, on the file of the High Court.

The petition coming on for hearing, upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of SRI P RAMA SHARANA SHARMA Advocate for the Petitioners, GP FOR REVENUE for the Respondents, the Court made the following.

ORDER

Learned Assistant Government Pleader for Revenue appearing for respondent Nos.1 to 4 and the learned Assistant Government Pleader for Home appearing for respondent No.5 seek time to get instructions. ✓

Learned counsel for the petitioners submitted that as per Ex.P1 - Bhu Bharati extract, the name of petitioner No.1 is recorded as pattadar for the subject land admeasuring Acs.3-2000 guntas in Survey No.314/172 of Samathsingaram Village, Manuguru Mandal, Bhadradri Kothagudem District. ✓

Learned Assistant Government Pleader for Revenue submitted that petitioner No.1 does not have pattadar pass book and it appears there is a dispute, as such, in Ex.P1 - Bhu Bharati extract, there is an entry in the column of land status as 'Not Signed - Dispute in Succession', and it needs to be verified. ✓

However, considering the Bhu Bharati extract (Ex.P1), *status quo*, obtaining as on today, shall be maintained in respect of the subject land admeasuring Acs.3-2000 guntas in Survey No.314/172 of Samathsingaram Village, Manuguru Mandal, Bhadradri Kothagudem District, till the next date of hearing. However, this order shall not come in the way of the respondents, if any action is sought to be taken against the petitioners, by following due process of law.
