WHEREAS the Petitioner above named through his Advocate Sri. GUDI MADHUSUDHAN REDDY presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an order or direction more particularly one in the nature of Writ of Mandamus declaring the respondents in attaching the salary of the petitioner vide order dated 24.01.2026 in EP No. 195 OF 2021 in Arb No 239 OF 2017 on the file of Illrd Addl. Senior civil Judge at Ranga reddy Dist at LB Nagar as arbitrary and contrary to the provisions of law and contrary to the law laid down by Division Bench of this Honble court I Punyarnurthala Venkat

viswa sundara rao vs margadarsi chit fund private ltd reported in 2017 (3) ALD 387 consequently to set aside the attachment of salary order dated 24.1.2026 in EP No. 195 OF 2021 in Arb No 239 OF 2017 on the file of Illrd Addl.Senior civil Judge at Ranga reddy at LB Nagar,

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri. GUDI MADHUSUDHAN REDDY Advocate for the Petitioner, Government Pleader for Revenue General (Stamps and Registration) for respondent Nos.1 to 3, directed issue of notice to the Respondents 4 to 6 herein to show cause as to why this WRIT PETITION should not be admitted.

are directed to show cause on or before 27.07.2026 to which date the case stands posted as to why in the circumstances set out in the petition and the affidavit filed therewith (copy enclosed) this WRIT PETITION should not be admitted.

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to grant stay of all furhter proceedings in attaching the salary of the petitioner vide order dated 24.01.2026 in EP No. 195 OF 2021 in Arb No 239 OF 2017 on the file of Illrd Addl.senior civil Judge at Ranga reddy distrcat LB Nagar, Pending disposal of WP No 14645 of 2026. on the file of the High Court.

The Court made the following:

ORDER

Notice before admission.

Learned Government Pleader for Revenue General (Stamps and Registration) takes notice on behalf of respondent Nos.1 to 3, waives further notice and seeks time to file counter.

Registry is directed not to take out notice to respondents 1 to 3 in view of the above waiver.

The learned counsel for the petitioner is permitted to take out personal notice to respondent Nos.4 to 6 and to file proof of service in the registry.

The learned counsel for the petitioner submits in *Punyamurthula Venkata Viswa Sundara Rao v. Margadarsi Chit Fund Private Limited, Hyderabad and others* [2017(3) ALD 387], the Division Bench of this Court held that the E.P. Court does not have jurisdiction to entertain an application for execution of the award passed by the Deputy Registrar of Chit Funds, if presented by the decree holder. However, in the instant case also, straightaway E.P.No.195 of 2021 in Arb.CF.No.239 of 2017 was filed before the III Additional Senior Civil Judge, Ranga Reddy district against the petitioner and others, without it being presented/forwarded by the Registrar. In view of the decision referred to above, balance of convenience is in favour of the petitioner.

Hence, there shall be interim stay as prayed for insofar as petitioner is concerned.
