No. 385 of 2025 had approached this Court and filed Crl.P.No.10652 of 2025, wherein this Court while ordering notice before admission, granted stay of all further proceedings and the criminal petition is pending and the petitioner is also entitled for the very same benefit.

In view of the above submissions, the Registry is directed to verify and list this criminal petition along with Crl.P.No.10652 of 2025 on 05.08.2026.

Till then there shall be an interim stay of all further proceedings against petitioner/accused No.2 in C.C.No.385 of 2025 on the file VII Additional Junior Civil Judge-cum-VII Additional Metropolitan Magistrate at Hayathnagar, Ranga Reddy District.

In default of filing proof of service, the stay shall stand vacated.
