Chaman Lal Goyal*¹, there shall be an interim direction to the respondents to consider the case of the petitioner for promotion to the post of Tahsildar, as and when promotions are effected, without reference to the pendency of Criminal Case in C.C.No.3/2020 on the file of I Additional Special Judge for SPE & ACB cases, at Hyderabad
