WHEREAS the Petitioner above named through his Advocate Sri. CHIKKUDU PRABHAKAR presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ order or direction, more particularly one in the nature of writ of mandamus declaring the action of the Respondents non allowing the petitioner Joining into Duty as Telephone Operator in the Respondent Department as an illegal, ex-facie, arbitrary, discriminatory, un just, un fair, un reasonable, un lawful and un constitutional, irrational, whimsical and in violation of Principles of Natural Justice and in violation of the provisions of the Rights of persons with disabilities Act , 2016 and in violation of Article 14,16 and 21 of the Constitution of India and in violation of the Judgments of Hon'ble Supreme Court in the case of Bhagwan das and another V/s. Punjab State Electricity Board which is reported in 2008(I) SCC 579 and set aside the same and consequently, direct the 2nd Respondent to allow the petitioner join in to the duty of the Telephone Operator in the Respondents Department;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri CHIKKUDU PRABHAKAR Advocate for the Petitioner, learned Government Pleader for Services takes notice on behalf of respondents, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
