Yards at Kondapur Village, Maseed Banda, Serilingampally Mandal, R.R District being carried out by Respondents 4 to 6 without any right and title to the property and permission or approved plan, inspite of our Representation dated- 28.10.2025 as highly illegal, arbitrary, capricious, contrary to law and opposed to the Principles of natural Justice and consequently direct the Respondents to take immediate steps and stop the illegal construction forth with.
