WHEREAS the Petitioners above named through their Advocate Sri M DAMODAR REDDY presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an order or direction more particularly one in the nature of Writ of Certiorari to call for the records of the impugned order dated 09.04.2025 passed by the 3rd respondent in file No. E1/65/2025 rejecting the succession application submitted by the petitioners for seeking mutation of the agriculture land in Sy. No.51/A, admeasuring Ac.7-00 guntas and Sy. No. 52/E, admeasuring Ac.0-07 total admeasuring Ac.7-07 guntas situated at Kondapur village, Ghatkesar Mandal, Medchal-Malkajgiri District as left by Late Dasari Sreeram Reddy though the other legal heirs of Late Sreeram Reddy have jointly signed on the succession application and also submitted their respective declarations including declaration of the mother of the 5th respondent by stating no

objection to mutate the names of the petitioners in the revenue records as against the above land, as illegal, unlawful and contrary to law and same may be quashed by directing the respondents to grant succession of the above land only in the name of the petitioners and include their names in the Bhu Bharati portal and issue Bhu Bharati passbooks.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri. M DAMODAR REDDY Advocate for the Petitioners, directed issue of notice to the Respondent No.5 to show cause as to why this WRIT PETITION should not be admitted.
