WHEREAS the Petitioner above named through its Advocate M/s. C VIKRAM CHANDRA presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ, order or

direction, more particularly one in the nature of Writ of Mandamus declaring the actions of Respondent Nos.4,6,8 and 10 in issuing the order to the Respondent No.11 to freeze and hold the bank account of the Petitioner bearing A/c.No.247302000000127 of Federal Bank Ltd., Road No.3, Banjara Hills Branch, Hyderabad,Telangana allegedly in relation to an investigation into a Crime No. 08/2024 with Acknowledgement No. 33104240051028 dated 26-04-2024 of NCCRP Uttar Pradesh - Prayagraj, State of Uttar Pradesh, Case No. 1386/2024 with FIR No. 11206080240005/2024 dated 06-06-2024. Cyber Crime Police Station - Mehsana Dist. Gujarat, State of Gujrat, CEN PS FIR No. 363/2024 dated 10-05-2024 of CEN Police Station North - East Division, Yelahanka Bangalore City, State of Karnataka, Case No. 97-2024, dated 23-05-2024 of Odhisa Police - Insp. Teroskova Mohapatra, State of Odhisa, to which the Petitioner is neither connected nor concerned with and without any notice to the petitioner and without there being any FIR in the name of the Petitioner, and not reporting forthwith to the Jurisdictional Magistrate and not considering the Representation made by the Petitioner dt.13.03.2026 and dt.23.04.2026 as illegal and arbitrary and violative of the principles of natural justice and Article 21 and 300-A of the Constitution of India and thereby QUASH the freezing orders.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of M/s. C VIKRAM CHANDRA Advocate for the Petitioner and Deputy Solicitor General for respondent No.1 and Assistant Government Pleader for Home for respondent No.2, directed issue of notice to the Respondent Nos.3 to 11 herein to show cause as to why this WRIT PETITION should not be admitted.
