Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or Direction, more particularly one in the nature of a Writ of Mandamus, declaring the inaction of the respondents in not considering the petitioner's representation dated 26.06.2025 and in not releasing the honorarium due to the petitioner, amounting to Rs.12,20,000/- (Rupees Twelve Lakhs Twenty Thousand only) for the period from 01.06.2019 to 26.06.2024, pursuant to G.O.Rt.No.364, Law (E.II) Department, dated 05.06.2017, as illegal, arbitrary, and violative of the principles of natural justice and Article 14 of the Constitution of India, and consequently direct the respondents to forthwith release the said amount to the petitioner.

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the respondents, to release the aforesaid amount of Rs.12,20,000/- to the petitioner for the services rendered as Assistant Government Pleader for the Court of the Junior Civil Judge, Huzurnagar, Suryapet District, pending disposal of WP No 14877 of 2026, on the file of the High Court.
