WHEREAS the Petitioner above named through his Advocate Sri. APPA RAO VUPPUTURI presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ order or direction more particularly one in the nature of writ of Mandamus by declaring the actions of 3rd to 8th respondents herein in not execute the warrants issued by "**Telangana State Consumer Disputes Redressal Commission Hyderabad**" (**Judicial First Class Magistrate in terms of sec.27 of Consumer Protection Act**) as illegal arbitrary contrary to principles of natural justice besides principles laid down herein,

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri. APPA RAO VUPPUTURI Advocate for the Petitioner, Assistant Government Pleader for Home for respondent Nos.1 to 8, directed issue of notice to the Respondent Nos.9 to 11 herein to show cause as to why this WRIT PETITION should not be admitted.

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the **"Telangana State Consumer Disputes Redressal Commission Hyderabad Addl Bench"** (Judicial First Class Magistrate in terms of sec27 of Consumer Protection Act) not to dispose the EA Nos. 29,27, 22, 25, 24, 23 & 26 of 2024 pending disposal of writ petition without execution of warrants by 3rd to 8th respondents , Pending disposal of WP No 14754 of 2026, on the file of the High Court.

The Court made the following:

ORDER

Notice before admission.

Learned Assistant Government Pleader for Home takes notice on behalf of respondent Nos.1 to 8 and waives further notice. He seeks time to obtain instructions and make submissions.

Issue notice to respondent Nos.9 to 11.

Personal notice is permitted.

Learned counsel for the petitioner submits the Telangana State Consumer Disputes Redressal Commission had issued bailable as well as non-bailable warrants on respondent Nos.9 to 11 herein in E.A.Nos.29, 27, 22, 25, 24,23 and 26 of 2024 in the years, 2024 and 2025 under Section 27 of the Consumer Protection Act, 1986 and directed the Commissioner of Police, Gachibowli, Cyberabad to secure their presence and to produce them before the Commission. But the said warrants are not yet executed.

Learned Assistant Government Pleader for Home seeks time to furnish the documents to support his contention that the Telangana State Consumer Disputes Redressal Commission is not empowered to direct respondent-Police for execution of warrants against respondent Nos. 9 to 11.

This matter requires detailed examination.

The facts can be ascertained only upon filing counter by respondents.
