WHEREAS the Petitioner above named through their Advocate Sri. G B S S PAPA RAO presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court

may be pleased to issue a writ, order or direction more particularly one in the nature of writ of mandamus declaring the inaction of the respondent Nos. 2 to 4 for not taking any action against the illegal constructions made by the unofficial respondent Nos. 6 and 7 in the premises of CSI Christ Church, Bhadrachalam, Bhadradi Kothagudem District, is illegal, arbitrary, unjust and violation of the Article 21 and 300-A of the Constitution of India and consequently direct the respondents 2 to 4 to take appropriate action against the illegal constructions and demolish the illegal constructions carried on by the unofficial respondents 6 and 7 in the premises of CSI Christ Church, Bhadrachalam, Bhadradi Kothagudem District, and pass.

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri. G B S S PAPA RAO Advocate for the Petitioner, Assistant Government Pleader for Panchayat Raj and Rural Development, for respondent Nos.1 and 3, Assistant Government Pleader for Revenue, for respondent No.2, directed issue of notice to the Respondent Nos.5 to 7 herein to show cause as to why this WRIT PETITION should not be admitted.
