ORDER

This application is filed for the petitioner-respondent seeking to suspend the operation of the order, dated 18.02.2026 in CrI.M.P.No.151 of 2025 in M.C.No.17 of 2025 passed by the learned Judge, Family Court-cum-III Additional District and Sessions Judge, Mahabubnagar.

The contention of learned counsel for the petitioner is that not earning anything and he is a student; that the petitioner is pursuing M.A. English and hence, he prays this Court to enhance the maintenance granted to respondent No.2.

Considering the submission made by learned counsel for the petitioner, the operation of the order, dated 18.02.2026 in CrI.M.P.No.151 of 2025 in M.C.No.17 of 2025 passed by the learned Judge, Family Court-cum-III Additional District and Sessions Judge, Mahabubnagar, is suspended and reducing the maintenance from Rs.6,000/- per month to Rs.4000/- per month and arrears of maintenance has to be paid at the same rate, pending disposal of the Criminal Revision Case.
