WHEREAS the Petitioner above named through his Advocate SRI K. JAMALI presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction more particularly one in the nature of Writ of Mandamus declaring the actions of the Official Respondents more particularly the Respondent No.2 in passing the Speaking Order dt.12/03/2026 vide File No.G1/2832/2025 revoking the Building Permission vide No.016841/SIDD/00250/IABP/2025 dt.17/10/2025 sanctioned in favour of the Petitioner until such dispute is adjudicated, inspite of receiving the Petitioner's Explanation dt.09/01/2026 as being Unjust, Arbitrary and Discriminatory in nature, violative of Articles 14, 21 and 300-A of the Constitution of India, in the Interest of Justice.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of SRI K. JAMALI Advocate for the Petitioner, GP FOR MUNICIPAL ADMINISTRATION AND URBAN DEVELOPMENT for the Respondent no.1 and SRI KRISHNA REDDY PUTTA, Standing Counsel for MUNICIPALITIES for the Respondent no.2 directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.

There shall be status quo existing as on date on the subject property. The petitioner is directed not to make any further constructions. It is clarified that if any constructions are made in deviation to the orders passed by this Court, it is left open to the respondents to take appropriate action
