WHEREAS the Petitioner above named through his Advocate SRI K.M. SRAVENTHY SIMHA presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or direction more particularly one in the nature of writ of MANDAMUS, declaring the action of the respondents No.6 and 7 herein are nothing but abuse of power, without disclosing any complaint and without registering any FIR, repeatedly calling the petitioner to come to the P.S KPHB, threatening the petitioner to settle the matter in their presence with the daughter-in-law (Manga) of landlord, is unreasonable, illegal, arbitrary, against the principles of natural justice and violative of Article 14 and 21 of the Constitution of India and consequently direct the Respondent No.6

and 7 not to harass the petitioner by repeatedly calling him to present before the respondent No.7.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of SRI K.M. SRAVENTHY SIMHA Advocate for the Petitioner and AGP FOR HOME for the Respondents no. 1 to 5 directed issue of notice to the Respondents no. 6 and 7 herein to show cause as to why this WRIT PETITION should not be admitted.

2. Mr. Rajshekar Reddy, Occ SHO Attached to KPHB PS, Kukatpally, Hyderabad

are directed to show cause on or before 13.07.2026 to which date the case stands posted as to why in the circumstances set out in the petition and the affidavit filed therewith (copy enclosed) this WRIT PETITION should not be admitted.

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to restrain the Respondent No.6 and 7 and not to call the petitioner herein to present before the respondent No.7, pending disposal of WP No 14878 of 2026, on the file of the High Court.

The Court made the following

ORDER:

Notice before admission.

Learned Assistant Government Pleader for Home appearing for respondent Nos.1 to 5 seeks time to obtain instructions or file counter.

Issue notice to respondent Nos.6 and 7.

Personal notice is permitted.

Learned counsel for the petitioner submits that at the behest of unofficial respondent Nos.6 and 7, official respondent No.5 is repeatedly calling the petitioner to Police Station and exerting pressure upon him to settle the disputes between the petitioner and unofficial respondent Nos.6 and 7.

This matter requires detailed examination.

The facts can be ascertained only upon filing counter affidavit by unofficial respondent Nos.6 and 7.

In the meantime, as an interim measure, respondent No.5 is directed not to interfere with the personal life and liberty of the petitioner except by following the procedure contemplated under law.
