Meanwhile, the impugned order dated 06.02.2026 passed by the trial Court in M.P. No.91 of 2025 in M.C. No.398 of 2024 shall stand suspended in respect of respondent No.1 is concerned, subject to the condition that the petitioner shall pay an amount of Rs.7,500/- per month to respondent No.1 on or before the 10th day of every month and shall also pay arrears in the aforesaid ratio within a period of six (6) weeks from today. In default, the suspension order shall stand vacated.
