Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ order or direction, more particularly one in the nature of writ of Mandamus, declaring the action of the 1st respondent in not granting the access to the approach road as per the Lay out vide LP No. 363/86 at C. No. 6671/86/08 dt. 24/04/1986, in respect of the survey Nos. 244, 248, 263 situated at Shankerpally Village and Mandal, Ranga Reddy District, by considering the representation made by the petitioner dt. 21/12/2021 and 18/11/2021 as illegal, arbitrary, violation of principles of natural justice and against settled provisions of law and consequently direct the 1st respondent to consider the representation dt. 21/12/2021 and 18/11/2021 made by the petitioner by granting access to the approach road in Sy No. 244, 248, 263 situated at Shankerpally Village and Mandal, Ranga Reddy District as per the layout LP No. 363/86 at C. No. 6671/86/08 dt. 24/04/1986;

As an interim measure, the respondent No.1 is directed to consider the representations made by the petitioner on 21.12.2021 and 18.11.2021 seeking for granting access to approach road as per the layout vide LP.NO.363/86 at C.No.6671/86/08, dated 24.04.1986, in respect of the survey Nos.244,248,263, situated at Shankerpally Village and Mandal, Ranga Reddy District and pass appropriate orders, in accordance to law, within a period of two(02) weeks from the date of receipt of copy of this order, duly communicating the said decision to the petitioner.
