WHEREAS the Petitioners above named through their Advocate SRI CH CHAITANYA MITHRA presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, order or direction more particularly one in the nature of Writ of Mandamus declaring the inaction of Respondent Nos. 03 and 04 in preventing the illegal encroachment and fencing of the government land in Sy.No.42 of Alinagar revenue and in failing to protect and preserve Ayyammacheruvuof Gaddpotaram municipality, Sangareddy District, despite several representations and complaints, as illegal, arbitrary and unconstitutional and consequently direct the respondents 03 to 05 to remove the

illegal encroachments made by the 06th Respondent over the said Government land in Sy.No.42 of Alinagar revenue and the fencing done in AyyammaCheruvu, now in Gaddapotharam Municipality, while directing the 01st and 02nd respondents to cause an enquiry over the dereliction of duties by the respondents 03 to 05 in taking appropriate action in accordance with law against the said illegal activities.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri. CH CHAITANYA MITHRA Advocate for the Petitioners, GP FOR REVENUE, for the respondent Nos. 1, 3, 4 & 5 and GP FOR MUNICIPAL ADMINISTRATION, for the respondent No.2, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
