P R BHARATH KUMAR presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to Issue writ order or direction more particular one in Nature of Writ of Mandamus Declaring the inaction of respondents 2 to 4 in respect of unauthorised Construction being carried out by respondents 5 to 7 in an extent of 240 Square Yards situated at H. No. 1-9-137, Kushaiguda, Medchal- Malkajgiri District is as arbitraary, illegal and violative of Art.14 and 21 of the Constitution of India as arbitraary, illegal, discriminatory besides voilation of

Hyderabad Municipal Corporation Act and consequently to direct 3rd Respondent to take proper and necessary steps for demolition of construction.

P R BHARATH KUMAR Advocate for the Petitioner, Sri Srinivas Rao Pachwa, for R2 to R4 directed issue of notice to the Respondent No.5 herein to show cause as to why this WRIT PETITION should not be admitted.
