Commissioner of Police, so as to ensure a fair, impartial, comprehensive, scientific and effective investigation.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri. GARLAPATI PRASHANTH Advocate for the Petitioner, Mr. M Srinivas, Asst GP FOR HOME, for the respondent Nos. 1 to 5, directed issue of notice to the Respondent No.6, herein to show cause as to why this WRIT PETITION should not be admitted.
