WHEREAS the Petitioner above named through his Advocate Sri. SWAMY VENKAT, TMP presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction more particularly one in the nature of Writ of Mandamus declaring the action of the Respondents 6 and 7 in illegally detaining the petitioner, subjecting him to custodial harassment, and extracting money under coercion without following due procedure established by law, as illegal, arbitrary, unconstitutional and violative of Articles 14, 19 and 21 of the Constitution of India, Consequently. direct an independent inquiry by Respondent No.2 into the illegal acts of the Respondent Police Officials, including custodial harassment and abuse of power, and to take appropriate action in accordance with law,

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri. SWAMY VENKAT, TMP Advocate for the Petitioner, Mr. M.Srinivas, Assistant Government Pleader for Home for respondent Nos.1 to 5, directed issue of notice to the Respondent Nos.6 & 7 herein to show cause as to why this WRIT PETITION should not be admitted.
