WHEREAS the Petitioners above named through their Advocate Sri M DAMODAR REDDY presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an order or direction more particularly one in the nature of Writ of Mandamus declaring the action of the respondents 2 to 4 in proposing to implement the names of the unofficial respondents in the ROR of the agricultural land of the petitioners in Sy. No. 142, 143, 145, 147, 148, 153, 154, 156, 157, 159, 164, 167, 173, 175 and 177 total admeasuring Ac. 43.00 gts., out of Ac. 60-00 gts, situated at Gorregutta Village, Dahegoan Mandal, Asifabad District, without giving any notice to the petitioners, though the unofficial respondents have withheld the payment of the total sale consideration by executing agreement dated 04-04-2019 to the effect that unless, until total sale consideration is being paid, they will not get mutate their names in the revenue records and though there is a direction by the Honourable High Court in WP No. 9841/2020 to the 4th respondent not to change the ROR entries, as illegal, unlawful and contrary to law and consequently direct the respondents 2 to 4 not to change the revenue record in respect of the above land from the names of the petitioners.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri. M DAMODAR REDDY Advocate for the Petitioners, directed issue of notice to the Respondent Nos.5 to 10 to show cause as to why this WRIT PETITION should not be admitted.
