He further submits that the matter before the trial Court has not been ripe for trial and is at the stage of summons.

Taking into consideration the age of the petitioner/accused No.1, his presence in C.C.No.557 of 2026 on the file of the IX Additional Judicial First Class Magistrate, Medchal at Medchal-Malkajgiri District, is dispensed with, subject to the condition that he shall be represented through his counsel on each and every date of hearing. If the presence of the petitioner/accused No.1 is required, he shall appear before the trial Court. In case of non-appearance on the specific date fixed by the trial Court for his appearance, the trial Court is entitled to proceed with the matter, in accordance with law.
