WHEREAS the Petitioner above named through his Advocate Sri. JILLELLA RAJESWAR RAO presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or Direction, more particularly one in the nature of Writ of Mandamus, declaring the action and inaction of the respondents in not considering the representations Dt. 06-08-2021, Dt. 08-04-2022, Dt. 19-12-2024, Dt. 16-01-2025, Dt. 23-02-2026 of the petitioner and in failing to protect the Government land in Sy.No.157 admeasuring Ac.21-26 guntas situated at Muripirala Village, M. Atmakoor Mandal, Yadadri Bhuvanagiri District, from encroachers and eviction/ Remove illegal constructions.

Consequently, direct the respondents to consider and dispose of the representations of the petitioner (Dt. 06-08-2021, Dt. 08-04-2022, Dt. 19-12-2024, Dt.16-01-2025, Dt. 23-02-2026) for assignment of the aforesaid Government land, strictly in accordance with law, relevant Government policies/schemes for assignment to landless poor persons, and within a time-bound period.

Declare that the revenue entries, mutations and sale transactions, including the regd. Sale deed Doc. No. 3019 of 2007 and Doc.No.893/2018, as in respect of Sy.No.157, having been made without lawful title over Government land, are illegal, void ab initio and not binding on the State or the petitioner, and consequently direct the respondents not to act upon or give effect to such entries/transactions,

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri. JILLELLA RAJESWAR RAO Advocate for the Petitioner, directed issue of notice to the Respondent Nos. 5 to 11 herein to show cause as to why this WRIT PETITION should not be admitted.
