Petition Under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to stay the operation of the order and decree dated 04-02-2025 passed in M.V.O.P.No.322 of 2019 on the file of the Court of the Motor Accidents Claims Tribunal - Cum - III Additional District Judge, Mahabubnagar, Pending disposal of MACMA No.730 of 2025, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and the order of the High Court dated 20.06.2025 made in IA No.2 of 2025 and upon hearing the arguments of SRI A RAMAKRISHNA REDDY Advocate for the Petitioner in IA No.2 of 2025 and Respondent No.1 in IA No.3 of 2025 and of SRI MOHAMMAD NASEER PASHA Advocate for the Respondent No.1 in IA No.2 of 2025 and Petitioner in IA No.3 of 2025, the Court made the following

### **ORDER**

**This application is filed seeking to permit the claimant to withdraw half of the compensation amount deposited by the Insurance Company (appellant) in pursuant to the orders passed by this Court on 20.06.2025.**

**This Court by order, dated 20.06.2025 in I.A. No. 2 of 2025 granted stay of execution of the decree passed in M.V.O.P. No. 322 of 2019 on the file of the Motor Accident Claims Tribunal-cum-III Additional District Judge, Mahabubnagar, on condition of appellant-Insurance Company depositing 50% of the decretal amount together with costs and interest.**

**Now, it is submitted by the learned Standing Counsel for the appellant that the conditional order has already been complied with by**

depositing 50% of the decretal amount together with costs and interest as directed by this Court.

Therefore, the interim stay granted by this Court dated 20.06.2025 is made absolute and the claimant is permitted to withdraw the amount already deposited by the appellant-Insurance Company together with costs and interest without furnishing any security.

Accordingly, the application stands disposed of.
