Learned counsel for the petitioners further submits that the matter before the trial Court has not been ripe for Trial and is at the stage of furnishing of sureties.

Post on 03.09.2026.

The presence of the petitioner Nos.1, 2, 4 to 6/accused Nos.1, 2, 4 to 6 in C.C.No.196 of 2022 on the file of the II Additional Junior Civil Judge-II Additional Judicial Magistrate of First Class at Medchal-Malkajgiri District at Kushaiguda, is dispensed with, subject to the condition that they shall be represented through their counsel on each and every date of hearing. If the presence of the petitioner Nos.1, 2, 4 to 6/accused Nos.1, 2, 4 to 6 is required, they shall appear before the trial Court. In case of non-appearance on the specific

date fixed by the trial Court for their appearance, the trial Court is entitled to proceed with the matter, in accordance with law. No relief is granted in so far as petitioner No.3/accused No.3 is concerned.
