WHEREAS the Petitioner above named through his Advocate SRI SUJITH JAISWAL presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to pass an order, direction or writ more particularly one in the nature of Writ of Certiorari declaring the action of Respondents more particularly Respondent Nos.2 to 4 herein for erroneously appointing Respondent No.5 as Representative for Urdu Big Daily Newspaper in the District Media Accreditation Committee(DMAC) vide Impugned Proceedings dt 08.04.2026 bearing No.010432/MRA/KBA/ 2026-28 in spite of lacking eligibility under Rule 10(e) of Telangana media Accreditation Rules, 2025 under G.O.Ms.No.252, GA(l and PR) Department, dt 22.12.2025 while ignoring the

Nomination/Appointment of Petitioner herein who is senior most journalist in KomuramBheem Asifabad District working since 2002 as Full time Journalist in SIASAT Urdu Big Daily Newspaper as arbitrary, illegal, violative of Principles of Natural Justice and consequently set aside the Impugned Proceedings bearing No.010432/MRA/KBA/2026-28 dt 08.04.2026 by directing the Respondents Nos.2 to 4 to appoint Petitioner as Representative for Urdu Daily Newspaper in the District Media Accreditation Committee(DMAC) of KomuramBheem Asifabad District.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri. SUJITH JAISWAL Advocate for the Petitioner, GP FOR INFORMATION AND PUBLIC RELATION, for the respondent Nos. 1 & 2 & 4 and GP FOR REVENUE, for the respondent No.3, directed issue of notice to the Respondent No.5, herein to show cause as to why this WRIT PETITION should not be admitted.
