WHEREAS the Petitioners above named through their Advocate Sri. NARENDAR JALLI presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction more particularly one in the nature of WRIT OF MANDAMUS to declare the action of the official respondents in reopening the Application Nos.ROS022003223540, ROS022002802304, ROS022002804866 and ROS022002805668 of the unofficial respondents by issuing

notice, dated 08.04.2026 to mutate the lands of the petitioners in Sy.No.18 admeasuring Ac.1.20 gts, Sy.No.19 admeasuring Ac 0.05 gts, Sy.No.20 admeasuring Ac.0.14 gts, Sy.No.22 admeasuring Ac 0.39 gts, Sy.No.30 admeasuring Ac.0.15 gts, Sy.Nos.31 and 32 admeasuring Ac.3.19 gts and Sy.No.30 admeasuring Ac.0.20 gts situated at Akbarjapet Village, Medchal Mandal, Medchal-Malkajgiri District on the names of the unofficial respondents, ignoring the succession application of the petitioners, as illegal, arbitrary, null and void and consequently to set aside the impugned notice, dated 08.04.2026 of the 3rd respondent,

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri. NARENDAR JALLI Advocate for the Petitioners and GP FOR REVENUE for Respondents 1 to 4 directed issue of notice to the Respondents 5 to 8 herein to show cause as to why this WRIT PETITION should not be admitted.

The Court made the following:

ORDER

Issue notice to respondent Nos.5 to 8.

Learned counsel for the petitioners is permitted to take out personal notice to respondent Nos.5 to 8 by Speed Post with Acknowledgment Due and file proof of service by the next date of hearing.

Heard Mr. Jalli Kanakaiah, learned senior counsel, appearing for Mr. Jalli Narender, learned counsel for the petitioners.

Mr. L. Ravinder, learned Assistant Government Pleader for Revenue, shall get instructions by the next date of hearing.

Learned senior counsel submitted that regularization applications submitted by respondent Nos.5 to 8 at Sl.Nos.4, 5, 9 and 14 under Ex.P2 have been rejected as per the report of the Tahsildar, Medchal Mandal dated 19.11.2025.

It is submitted that revenue authorities without any power have re-opened rejected regularization applications of respondent Nos.5 to 8 bearing Nos.ROS022003223540, ROS022002802304, ROS022002804866 and ROS022002805668, and issued impugned notices dated 08.04.2026, without jurisdiction.

In the light of above submissions submitted by learned senior counsel, there shall be interim suspension of notice dated 08.04.2026 issued by respondent No.3 in respect of the regularization applications bearing Nos.ROS022003223540, ROS022002802304, ROS022002804866 and ROS022002805668 of respondent Nos.5 to 8, until further orders.
