Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or Direction, more particularly one in the nature of writ of Mandamus, declaring the Highhanded action of the Respondent Nos. 2 to 4, in including the Petitioners Land admeasuring Ac. 13.33/13.32 gts in Sy.No.227/Part situated at Bhadurpally Village, Gandimaisamma-Dundigal Mandal, Medchal-Malkajgiri District, Telangana in prohibited List of Properties under Section 22A of the Registration Act, 1908 as bad in law, illegal, arbitrary, unlawful, ultravires,

prejudicial, unconstitutional, contrary to Orders Dt. 19.02.2026 passed in WP. No. 5229 of 2026 and Dt. 27.02.2026 passed in WP. No. 6312 of 2026 and violative of Articles 14, 21 and 300A of the Constitution of India and against the Principles of Natural Justice and consequently, direct the Respondents to forthwith remove the Petitioners land admeasuring Ac. 13.33/13.32 gts in Sy.No.227/Part situated at Bhadurpally Village, Gandimaisamma-Dundigal Mandal, Medchal - Malkajgiri District, Telangana, from the prohibited List of Properties maintained under Section 22A of the Registration Act, 1908.

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to suspend Land admeasuring Ac. 13.33/13.32 gts in Sy.No.227/Part situated at Bhadurpally Village, Gandimaisamma-Dundigal Mandal, Medchal-Malkajgiri District, Telangana from Prohibited List of Properties under Section 22A of the Registration Act, 1908, pending disposal of WP No 15282 of 2026, on the file of the High Court.

The petition coming on for hearing, upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of SRI S LAKSHMI KANTH Advocate for the Petitioners, GP FOR REVENUE for the Respondents, the Court made the following.

ORDER

Learned counsel for the petitioners submitted that in similar circumstances, this Court passed the order dated 19.02.2026 in W.P. No.5229 of 2026 and the order dated 27.02.2026 in W.P. No.6312 of 2026 and requested that similar order may be passed in this writ petition.

Hence, there shall be interim direction to the respondent authorities to remove the land admeasuring Acs.13-33/13-22 guntas in Survey No.227/part, situated at Bhadurpally Village, Gandimaisamma Mandal, Medchal-Malkajgiri District, from the prohibitory list of properties.
