Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, order or direction more particularly one in the nature of Writ of Mandamus declaring the action of the respondents No.1 to 3 in not releasing admitted retirement Benefits such as Pending Final payment of Gratuity (CAP Share) Bill Amount 13,82,029/- STO Token No.2600669584 dated 04/07/2025., and Gratuity (TG Share) Bill Amount 2,17,971/- STO Token No.2600669587 date 04/07/2025 and Commutation (CAP Share) Bill Amount 18,87,597/-STO Token No.2600669589 dated 04/07/2025, and Commutation (TG Share) Bill Amount 2,97,708/- STO Token No.2600669591 dated 04/07/2025, GPF Final Bill Amount 12,70,088 /- STO Token

No.2600445534 dated 02/06/2025, and Surrounder Leave/Final ELs and Half Pay Leave Encashment Bill Amount 15,26,291/-STO Token No.2600503741 dated 09/06/2025, and 12 Months PRC Monetary Bill Amount 3,02,293/- STO 12 Token Nos dated 09/06/2025/and 3rd respondent department issued PPP ID No.12104209 and PPO.No.09-027339/SP, dated 09/06/2025, even after finalizing the bills and having generated in Integrated Financial Management and Information System (IFMIS), inspite of repeated requests as illegal, arbitrary, unreasonable and violative of Articles 14,16, and 21 of the constitution of India and consequently direct the respondents No.1 to 3 herein to release and pay the admitted retirement Benefits such as Pending Final payment of Gratuity (CAP Share) Bill Amount 13,82,029/- STO Token No.2600669584 dated 04/07/2025, and Gratuity (TG Share) Bill Amount 2,17,971/- STO Token No.2600669587 date 04/07/2025 and Commutation (CAP Share) Bill Amount 18,87,597/-STO Token No.2600669589 dated 04/07/2025, and Commutation (TG Share) Bill Amount 2,97,708/- STO Token No.2600669591 dated 04/07/2025, GPF Final Bill Amount 12,70,088 /- STO Token No.2600445534 dated 02/06/2025, and Surrounder Leave/Final ELs and Half Pay Leave Encashment Bill Amount 15,26,291/-STO Token No.2600503741 dated 09/06/2025, and 12 Months PRC Monetary Bill Amount 3,02,293/- STO 12 Token Nos dated 09/06/2025, and along with interest @18 percent per annum

ORDER:

Heard Sri Ramu Nallamothe, learned counsel for the petitioner and learned Assistant Government Pleader for Services-III appearing for the respondents and perused the material on record. With their consent, this Writ Petition is taken up for disposal at the stage of admission itself.

2. Learned counsel for the petitioner submits that the petitioner filed the instant Writ Petition questioning the action of the respondents in not releasing the petitioner's retiral

benefits, despite token numbers having already been raised by the respondent authorities for payment of the amounts payable to the petitioner.

3. Learned counsel for the petitioner further submits that the *lis* raised in the present Writ Petition has already been adjudicated by the Division Bench of this Court in W.P.No.23138 of 2025, which was disposed of *vide* order dated 03.09.2025, and thus prayed to pass a similar order in the present Writ Petition also.

4. Learned Assistant Government Pleader for Services-III did not dispute the submissions made by learned counsel for the petitioner with regard to the disposal of W.P.No.23138 of 2025 dated 03.09.2025 and submits that the respondents will release the amounts on a priority basis of the token numbers and prayed this Court to pass appropriate orders.

5. Having regard to the above made submissions and for the reasons alike in the order dated 03.09.2025 passed by the Division Bench of this Court in W.P.No.23138 of 2025, this Writ

Petition is disposed of directing the respondents to ensure that the entire amount payable to the petitioner is released as expeditiously as possible, preferably within a period of six (6) weeks from today, failing which, the entire amount with regard to the retiral benefits shall carry interest at the rate of 10% per annum, from the date the amount fell due, till the actual date of its payment.

Miscellaneous petitions pending, if any, in this Writ Petition, shall stand closed. There shall be no order as to costs.

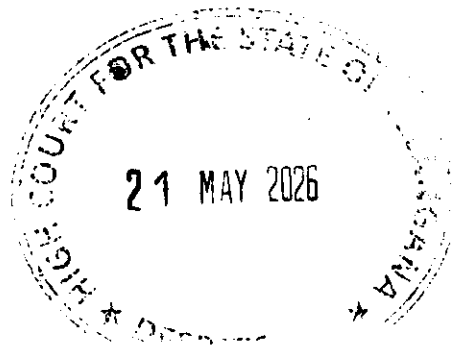
