WHEREAS the Petitioner above named through his Advocate Sri SATYANARAYANA DHARMAPURI presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to Issue a Writ of Mandamus declaring the inaction of the official respondents in not acting upon the petitioner's representation dated 20.04.2026 and in not preventing the illegal encroachment and unauthorized construction done by respondent no. 5, 6 & 7 as illegal, improper, arbitrary,

unconstitutional and against the principles of natural justice, consequently direct the respondents to consider petitioner representation dated 20-04-2026, demolish, remove the illegal and unauthorized/illegal construction made by respondent over the petitioner's land in Plot No. 119 & 144 admeasuring 239 Square yards and 269 Square Yards respectively in Survey No. 431, 432, 439, 440, 441, 442 & 443, situated at Tharamathipet, Abdullahpurmet Mandal, Ranga Reddy District, TG by demolishing illegal structures made in Plot No. 120 in Survey No.431, 432, 439, 440, 441, 442 and 443, situated at Tharamathipet, Abdullahpurmet Mandal, Ranga Reddy District, TG and Plot No.1,2,3 in survey No. 422/Part.

AND WHEREAS the High Court upon perusing the Writ Petition and affidavit filed herein and upon hearing the arguments of Sri. SATYANARAYANA DHARMAPURI Advocate for the Petitioner, directed issue of notice to the Respondent Nos.5 to 7 to show cause as to why this WRIT PETITION should not be admitted.
