Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the nature Writ of Mandamus declaring the action of the Respondent No. 3 in trying to collect the loan amount in a threatening manner by engaging anti-social elements and threatening the

petitioner and his family with dire consequences, further not send any mails to the employer of the office where the petitioner works and not to send any person to the palace of employment for payment loan amounts, pending disposal of WP No 15347 of 2026, on the file of the High Court.

The court while directing issue of notice to the Respondents herein to show cause as to why this application should not be complied with, made the following. (The receipt of this order will be deemed to be the receipt of notice in the case).

ORDER:

Sri P. Hari Prasad, learned counsel for respondent No.3 present virtually.

The petitioner has taken loan from the respondent No.3 and said loan account has been declared as Non-Performing Asset (NPA). Subsequent to the said declaration the respondent No.3 has sent E-mail dated 21.04.2026 to the employer of the petitioner intimating about the loan taken and its declaration as NPA. On account of said E-mail, the petitioner apprehends risk to his employment, consequently, risk to his livelihood.

Further the petitioner submits that he has already provided security for the loan taken and therefore, there is no occasion the respondent No.3 to communicate with his employer.

In the circumstances stated, the respondent No.3 is directed not to send any further E-mails to the employer of the petitioner.

During pendency of the writ petition, the respondent No.3 is directed to follow the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 in realizing the loan amount i.e., not to engage anti-social elements for the said purpose.

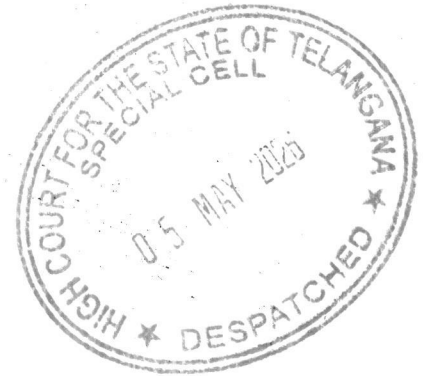
