No. 181 admeasuring Ac. 01-28 gts situated at Govardhanagiri Village, Raghunathapally Mandal, Jangaon District as bad, arbitrary, illegal, unfair and unconstitutional and consequently direct the respondent No.3 to issue Pattadar Passbook in respect of the land admeasuring Ac.01-28 gts in Sy.No.181 situated at Govardhanagiri Village, Raghunathapally Mandal, Jangaon District in the name of the petitioner and Shankari Srikanth and Shankari Parusharamulu by deleting the name of T.Ashwin Kumar Singh forthwith;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri. C Ruthwik Reddy Advocate for the Petitioner,

directed issue of notice to the Respondent No. 5 to 7 herein to show cause as to why this WRIT PETITION should not be admitted.

Learned counsel for the petitioner is permitted to take out personal notice to respondent Nos.5 to 7 by Speed Post with Acknowledgment Due and file proof of service by the next date of hearing.

As it is submitted by learned counsel for the petitioner that impugned order dated 19.10.2024 in Rc.No.B/1984/2024 was passed without issuing any notice to the petitioner, in violation of principles of natural justice, *status quo*, obtaining as on today, shall be maintained in respect of land admeasuring Acs.01-28 guntas in Survey No.181 of Govardhanagiri Village, Raghunathapally Mandal, Jangaon District, till the next date of hearing.
