Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ of Mandamus any other appropriate Writ, Order or Orders, Direction or Directions to declare the action of the 6th respondent in rejecting the findings of the Joint Survey conducted by the Irrigation and Revenue Departments for re-fixation of FTL and Buffer Zone

of Nalla Cheruvu, Narsingi Village, Gandipet Mandal, R.R.District through its letter No.693/COMM/HYDRAA/R.R.District/Re-PN/2026, dt.15.04.2026 as arbitrary, unreasonable and unconstitutional and to set aside the same and to issue a consequential direction to the 6th Respondent to issue Final Notification in respect of the Nalla Cheruvu, Narsingi Village, Gandipet Mandal, R.R.District basing on the joint re-survey in pursuance to the directions in WP No.31484/2023 by excluding Sy.No.176 from the FTL.

District, basing on the Preliminary Notification, dt.23.07.2014, pending disposal of WP No 15417 of 2026, on the file of the High Court.

SIDDHARTH GOUD, Counsel Representing MR. V. NARSIMHA GOUD, Standing Counsel for HMDA for the Respondents no. 4 and 5, MR. SAMEER AHMED, Standing Counsel for HYDRAA for the Respondent no.6 and MR. LAXMALLA SANDEEP, AGP FOR IRRIGATION, for the Respondents no. 2 and 8, the Court made the following.

Learned Standing Counsel for HYDRAA submitted requested this Court that the matter may be taken up on 06.05.2026.

However, considering the report *vide* Lr. No.693/COMM/HYDRAA/R.R.Dist/Re-PN/2026 dated 15.04.2026 submitted by respondent No.6 to respondent No.7 wherein it was observed that that there are no visible traces of water stagnation in Survey No. 176 of Narsingi Village which according to the learned Senior Counsel was not properly acted upon by respondent No.6, *status quo* obtaining as on today shall be maintained in

respect of the subject lands of the petitioners in Survey No. 176 of Narsingi Village, Gandipet Mandal, Ranga Reddy District, till the counter is filed respondent No.6.
