Having regard to the submissions made by the learned counsel for the petitioner and in view of the law laid down by the Hon'ble Apex Court in *State of Punjab v. Chaman Lal Goyal*¹, there shall be an interim direction to the respondents to consider the case of the petitioner for promotion to the post of Motor Vehicles Inspector, as and when promotions take place, without reference to the C.C.No.98 of 2024 (F.I.R.No.01/RCT-CIU-ACB/2020 dated 29.01.2020) on the file of First Additional Special Judge for SPE & ACB Cases, Hyderabad, if otherwise eligible.
