WHEREAS the Petitioner above named through his Advocate M/s. VENKATARAMANAI AH K presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue writ order or direction more particularly in the nature of Writ of Mandamus declare the action of the Respondents more particularly Respondent, No.3, in unilaterally registering Cancellation of Irrevocable General Power of Attorney deed dated 24-04-2026, bearing Document No.101/IV/2026, purporting to cancel the registered Irrevocable General Power of Attorney (IRGPA) dated 22-03-2022, bearing Document No.156/IV/2022, executed in favour of the Petitioner as null and void and not binding on the Petitioner and consequently, set aside the subsequent Notice Vide.No.231/Kukatpally /2026 dated 25-04-2026 issued by the Third Respondent is illegal, arbitrary and violation of principles of natural justice.

AND WHEREAS the High Court upon perusing the petition and AFFIDAVIT filed herein and upon hearing the arguments of M/s. VENKATARAMANAIK Advocate for the Petitioner and Government Pleader for Stamps and Registration for respondent Nos. 1 to 3, directed issue of notice to the Respondent Nos.4 to 7 herein to show cause as to why this WRIT PETITION should not be admitted.

**The Court made the following:
ORDER:**

Notice before admission.

Learned Government Pleader for Stamps and Registration takes notice on behalf of respondent Nos. 1 to 3, waives further notice and seeks time to file counter.

Registry is directed not to take out notice to respondents 1 to 3 in view of the above waiver.

The learned counsel for the petitioner is permitted to take out personal notice to respondent Nos.4 to 7 and to file proof of service in the registry.

Learned counsel for the petitioner submits that in similar circumstances this Court has passed an interim order dated 05.05.2026 in W.P.No.15560 of 2026 and prays this Court to pass similar order in the present Writ Petition.

The above made submissions are not seriously disputed by the learned Assistant Government Pleader appearing for the respondents.

In view of the above, and for the reasons alike in the order dated 05.05.2026 in W.P.No. 15560 of 2026, there shall be interim suspension of the impugned document, viz., Cancellation of Irrevocable GPA deed dated 24.4.2026 vide Book No.4, Doc. No. 101/2026, SRO, Kukatpally.
