WHEREAS the Petitioners above named through their Advocate SRI KARRI MURALI KRISHNA presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, order or direction mostly one which is in the nature of a Writ of Mandamus declaring the Proceedings in D2/2799/2023. dt.13.10.2025 of the 2nd Respondent without issuing the Notices to the Petitioners as illegal, irregular, arbitrary, unjustified and unsustainable and consequently direct the 2nd Respondent herein to issue prior Notices to the Petitioners before passing any order.

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the 2nd Respondent to consider the Impleadment Petition filed by the Petitioners for impleading them as Respondents in the File No.D2/2799/2023 before passing any orders by giving prior notices to the Petitioner, pending disposal of WP No 15707 of 2026, on the file of the High Court.

The Court made the following

ORDER:

Issue notice to respondent Nos.3 to 16.

Learned counsel for the petitioners is permitted to take out personal notice to respondent Nos.3 to 16 through Speed Post with Acknowledgment Due and shall file proof of service by the next date of hearing.

The petitioners claim to be the persons interested in respect of the land admeasuring Acs.2-15 guntas in Survey No.452/2, situated at Puppalaguda Village, Gandipet Mandal, Ranga Reddy District by virtue of two agreements of sale dated 07.02.2020 (Exs.P3 and P4). That respondent No.2 is proceeding with the enquiry pursuant to the impugned Notice in File No.D2/2799/2023 dated 13.10.2025 without issuing notice to the petitioners.

Mr. L. Ravinder, learned Assistant Government Pleader for Revenue, submitted that the petitioners are alleged agreement holders and they do not have any *locus standi* to contest the proceedings.

However, considering the request of the petitioners that they have interest in the land admeasuring Acs.2.00 in Survey No.452/2 as agreement holders. There shall be an interim direction to respondent No.2 to consider the objections of the petitioners to the impugned notice dated 13.10.2025, by giving an opportunity to the petitioners to file objection/written statement of defence, along with documents. The same shall be filed, if not already filed, within a period of ten (10) days from the date of receipt of copy of this order.
