Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ or Order more particularly one in the nature of Writ of Mandamus, declaring the inaction of Respondents No.2 and 3 in not processing the Petitioner's Written Representation dated 01.07.2024 (submitted to Respondent No.2) and 15.04.2026 (submitted to Respondent No.3) to reopen the proceedings in CC Nos.616, 617, 618 and 619/G/75 to direct a fresh hearing to be conducted to declassify Petitioners' land admeasuring Ac. 6.00 Gts situated in Survey No.244 in Ravalkole Village, Medchal Mandal, Medchal- Malkajgiri District as surplus ceiling land as being illegal, arbitrary, unjust, violative of Articles 14 and 300A of the Constitution of India, 1950 and violative of Section 9A of the Telangana Land Reforms (Ceiling on Agricultural Holdings) Act, 1973 and to consequently direct Respondents No.2 and 3 to conduct a fresh hearing to be conducted in CC Nos.616, 617, 618 and 619/G/75 and declassify the Petitioners' land as ceiling surplus land and further remove the Petitioners' land admeasuring Ac. 6.00 Gts from the Prohibited Register maintained under Section 22A of the Registration Act, 1908.

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the Respondents No.2 and 3 to consider and dispose the Written Representation dated 01.07.2025 submitted to Respondent No.2 and 15.04.2026 submitted to Respondent No.3 by Petitioner No.1 on behalf of all Petitioners, pending disposal of WP.No.15607 of 2026, on the file of the High Court.

ORDER:

Respondent authorities are directed not to interfere with the possession of the petitioner in respect of the land admeasuring Acs.6-00 guntas in Survey No.244, situated at Ravalkole Village, Medchal Mandal, Medchal-Malkajgiri District, without following due process of law.
