The presence of the petitioner No.2/accused No.2 in C.C.No.228 of 2021 on the file of the XVI Additional Metropolitan Magistrate at Rajendranagar, Cyberabad, is dispensed with, subject to the condition that he shall be represented through his counsel on each and every date of hearing. If the presence of the petitioner No.2/accused No.2 is required, he shall appear before the trial Court. In case of non-appearance on the specific date fixed by the trial Court for his appearance, the trial Court is entitled to proceed with the matter, in accordance with law. No relief is granted insofar as petitioner No.1/accused No.1 is concerned.
